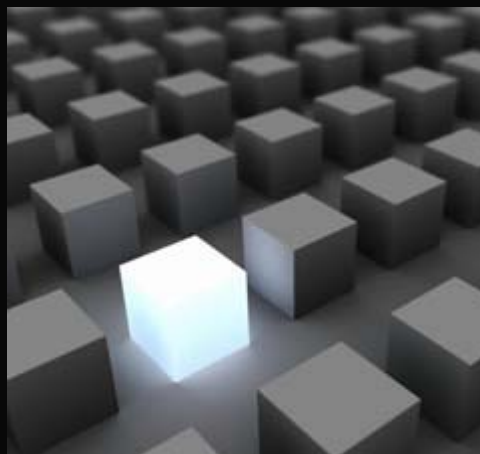

SOFTWARE LICENSE AGREEMENT

PLEASE READ THIS SOFTWARE LICENSE AGREEMENT (THIS "AGREEMENT") CAREFULLY BEFORE DOWNLOADING, INSTALLING OR USING THE SOFTWARE (AS DEFINED BELOW).

BY CLICKING ON THE "ACCEPT" BUTTON, DOWNLOADING THE SOFTWARE, INSTALLING THE SOFTWARE OR USING THE SOFTWARE, YOU ARE CONSENTING TO BE BOUND BY THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, CLICK THE "DO NOT ACCEPT" BUTTON AND REFRAIN FROM DOWNLOADING OR INSTALLING OR USING THE SOFTWARE OR ANY PORTION THEREOF. THE SOFTWARE IS COPYRIGHTED AND LICENSED (NOT SOLD).

1. Grant of License. Subject to payment of any applicable fees, **Gamma Telecom** (the "**Gamma**") grants to you a limited, non-exclusive license to use the mobile device software downloaded by you from Gamma (the "**Software**") as provided herein, solely for the purpose of **receiving Gamma's international least call routing services** (the "**Services**"), in accordance with the Software documentation (the "**Documentation**"; and the "**License**", respectively). The License allows you to install the Software on one (1) cellular telephone and to save one (1) copy of the Software on your personal computer for back-up. You may not make any other copies of the Software.

2. Other Rights and Limitations. You may not, and may not permit or aid others to, translate, reverse engineer, decompile, disassemble, update, modify, reproduce, duplicate, copy, distribute or otherwise disseminate all or any part of the Software, or extract or attempt to extract source code from the object code of the Software. The Software is licensed as a single product; you may not separate its component parts for any purpose. You may not make any commercial use of the Software, whether or not for consideration.

3. Proprietary Rights; Confidentiality. You acknowledge and agree that the Software is a proprietary product of Gamma and its licensors, protected under copyright laws and international treaties. You further acknowledge and agree that all right, title and interest in and to the Software, including associated intellectual property rights, are and shall remain with Gamma and its licensors. This Agreement does not convey to you any interest in or to the Software, except for a limited right of use as set forth herein, terminable in accordance with the terms of this Agreement. You will not remove, alter or deface any trademarks or proprietary notices of the Gamma or of its licensors in the Software.

4. Term and Termination. This Agreement is effective upon your clicking the "ACCEPT" button, downloading the Software, installing the Software and/or using the Software, and shall continue until terminated. Gamma may terminate this Agreement forthwith at any time upon the giving of written notice in case of any breach by you of this Agreement that has not been cured within fifteen (15) days following a written notice thereof from Gamma. Termination of this Agreement for any reason shall also terminate the License granted hereunder. Upon termination of this Agreement for any reason, you agree to destroy and remove from all cellular telephones, computers, hard drives and other storage media all copies of the Software and Documentation and, at the request of Gamma, shall so certify to Gamma that such actions have been performed.

5. Maintenance and Support. For a period of **twelve (12)** months from the date of download of the Software, you will be entitled to receive for no additional consideration maintenance and support services for the Software, in accordance with Gamma's standard terms. As of the end of such **twelve (12)** month period, you may purchase maintenance and support services from Gamma, in accordance with Gamma's standard terms. Maintenance and support services may be provided by the Gamma or its licensors.

6. Governing Law and Jurisdiction; Litigation Costs. This Agreement shall be construed and governed in accordance with the laws of **United Kingdom**, regardless of its conflict of laws rules, and the competent courts of **United Kingdom** shall have sole and exclusive jurisdiction over any dispute under this Agreement or otherwise related to the Software. If any action is brought by either party to this Agreement against the other party regarding the subject matter hereof, the prevailing party shall be entitled to recover, in addition to any other relief granted, reasonable attorney fees and expenses of litigation.

7. Miscellaneous. Should any term of this Agreement be declared void or unenforceable by any court of competent jurisdiction, such declaration shall have no effect on the remaining terms hereof. This Agreement represents the entire agreement between you and Gamma with respect to the subject matter hereof and they supersede any prior proposal, representation, or understanding between the parties. The failure of either party to enforce any rights granted hereunder or to take action against the other party in the event of any breach hereunder shall not be deemed a waiver by that party as to subsequent enforcement of rights or subsequent actions in the event of future breaches. YOU EXPRESSLY AGREE THAT THIS AGREEMENT IS ENTERED INTO ALSO FOR THE BENEFIT OF GAMMA'S LICENSORS OF THE SOFTWARE AND SUCH LICENSORS MAY EXERCISE ALL RIGHTS AND REMEDIES OF GAMMA HEREUNDER JOINTLY AND SEVERALLY.
